Regular Council Meeting August 1, 2022

Pursuant to due call and notice thereof; the regular meeting of the City Council of Rose Creek was held Monday, July 5, 2022, with the following present: Mayor Craig Weis, Council Members: Andrew Felten, Bobbie Greenlee, Mark Conradt, Wendel Sprung, Kristine Allas (Clerk/Treasurer), Public Works/Maintenance: Tom Lewison, Bob Jax.

Mayor Weis began the regular Council Meeting at 5:45 p.m. The Pledge of Allegiance was recited.

Council Woman Greenlee made the motion to approve the Agenda, with the addition of Ardella Bahr hall rental request, new dehumidifier, Council Man Felten seconded, and approved by Mayor Weis.

Council Man Conradt made the motion to approve the Minutes from the July 5, 2022, council meeting, Council Woman Greenlee seconded, and approved by Mayor Weis.

Creek Club: Kretta Menuey thanked the Council for all the support of the Creek Club and it's activities. There will be another Rose Creek Days Parade in July 7-9, 2023, as well as 507 Band, and fireworks. 2022 was of great success. The Halloween Spooktacular in October is the next planning event, with a Haunted Trail thru the Wayside Park. The concessional stand would like to get another Pepsi cooler (leaks inside and out), new floor mats with holes for fatigue, industrial fan (carpet drying fan), and shelving; and hoping to obtain an ice machine thru the City/Fire Dept.

Right Of Way: Rick Bottema would like the 2 dead oak trees in the alley taken down. He has spoken to Carter Contradt; Council Man Sprung made the motion for Conradt Tree Service to take the 2 oak trees down, Council Man Felten seconded, and motion approved by Mayor Weis.

Clerk Allas will order stencils for the Disc Golf platforms.

Clerk Allas requested hiring a person to go thru the newspapers for scapbooking articles, and to laminate, and help out in the office. Council Man Sprung made the motion to hire Melodie Triplett for \$10 per hour as a part time to assist Clerk Allas, Council Man Conradt seconded, and motion approved by Mayor Weis.

Clerk Allas passed out the drawings/estimate for all the Rose Creek Signs by Scenic Sign Corp, tabled for more information or other estimates.

Bob Jax requested a bigger dehumidifier for the old fire hall (west side); Council Man Sprung moved for Maintenance Bob Jax to purchase another dehumidifier from Adams Lumber, Council Man Felten seconded, and motion approved by Mayor Weis. Council Man Felten made the motion to approve the purchase of a leaf vacuum and lawn mower adaptor, Council Man Conradt seconded, and motion was approved by Mayor Weis. Summer Helper G Nelson will be asked to use the weedwacker on the south ditch, by bike trail, and culverts on Hwy 56. Charles Koenigs has been asked to look at lights in softball diamond area. Clerk Allas will contact

Tobe Troyer from Lime Springs to estimate the roof damage on the park pavilion and the what can be done with covering the inside ceiling of the park pavilion to stop birds from making a mess. Council Woman Greenlee made the motion for Pell Trucking to haul red dirt for the ball diamond approximately 24 ton (times 2 loads) should do it, Council Man Conradt seconded, and motion was approved by Mayor Weis. Also the ball diamond backstop and all fences was discussed for the Ulven Field.

Playground: Mayor Weis to check on a curly slide to be added. All the trees that Conradt Tree Service dropped, Bob Jax cleaned up very nicely. Boe Brothers to start site grading.

Council Man Sprung made the motion to pay all invoices and payroll, Council Man Conradt seconded, and approved by Mayor Weis.

Council Woman Greenlee made the motion to adjourn, Council Man Felten seconded and approved by Mayor Weis at 7:13 pm with the next meeting to be Tuesday, September 6, 2022, at 5:45 pm.
