## Regular Council Meeting June 5, 2023

Pursuant to due call and notice thereof; the regular meeting of the City Council of Rose Creek was held Monday, June 5, 2023, with the following present: Mayor Craig Weis, Council Members: Andrew Felten, Bobbie Greenlee, Mark Conradt, Wendel Sprung, Kristine Allas (City Clerk/Treasurer), Public Works: Bob Jax, Kretta Menuey

Mayor Weis began the regular Council Meeting at 5:45 p.m. The Pledge of Allegiance was recited.

Council Man Sprung made the motion to accept the Agenda as written, Council Man Conradt seconded, and approved by Mayor Weis.

Council Man Felten made the motion to approve the Minutes from May 1, 2023, Council Meeting, Council Woman Greenlee seconded, and approved by Mayor Weis.

Sheryl Taylor requested from the City, to cut curb and make a driveway entrance to her property off Oak Street, which would consist of 12' angled cement into a 10' wide driveway, up to 8' long. She has completed the locates and would like the water shutoff within the cement. Council Man Felten made the motion to approve the request with no cost to the City, Council Man Sprung seconded, and after hearing much discussion on the topic with Clerk Allas to contact Freeborn Mower Coop regarding if it is an option to move the electrical pole, Council Man Felten retracted his motion before a vote was called.

Kyle & Sarah Mergen requested the City review the videos taken of their wastewater piping from their home to the main, and the video taken of the main on 4<sup>th</sup> St, and the invoices, (the 3<sup>rd</sup> time it has backed up, and the plug in the main) they presented be paid partially from the City. After much consideration and discussion, Council Man Felten moved to approve the City to pay \$4,250.50 with the condition that the Mergens repair all the piping from their home to the City's main, Council Man Sprung seconded, and approved by Mayor Weis. Council Man Felten asked to amend his motion so that Clerk Allas will write a check to reimburse them immediately, Council Man Sprung agreed, and the motion passed and approved by Mayor Weis.

Council Man Sprung requested approval to apply for the Fire Department to provide BINGO at the park during Rose Creek Days July 7-9<sup>th</sup>; Council Man Conradt made the motion to approve the Rose Creek Fire Department Application to Conduct Off-Site Gambling, and Clerk Allas will mail it in, Council Woman Greenlee seconded, and approved by Mayor Weis.

Creek Club: Kretta Menuey gave the report that the meeting is this Thursday at 6:30 pm, and the Creek Club has decided to celebrate Maureen Schmidt as grand marshall of the parade for this year. Kretta requested that someone from the City Council/Staff drive the truck for Maureen to ride in if possible, and that the Creek Club would like to purchase a plaque to add the grand marshalls name plates each year.

Juneteenth/Holiday Resolution 2023-6-5: Council Man Sprung made the motion to accept and approve the Resolution clarifying the Holidays, Council Woman Greenlee seconded, and passed unanimously and approved by Mayor Weis.

Kretta Menuey asked the Council for an update on the Ordinances the committee is working on. Council Man Conradt reported that he believes the Animal Ordinance is sufficient in regard to the dog ordinance, and residents need to call law enforcement and have it documented when they report it. Council Man Conradt made the motion for Clerk Allas to communicate with Attorney Gilchrist regarding Ordinance research and changes/drafts, Council Man Felten seconded the motion, passed unanimously, and approved by Mayor Weis.

Update on the Spring Clean-up May 20: 1.6 ton, and it will cost approximately \$600.

Website Review: Clerk Allas is receiving training/help from Municipal Impact to upload information and pictures, is hoping for official launch before the utility bills are sent out to residents for 2<sup>nd</sup> quarter.

Bob Jax reported that the west lift station pump went down Memorial Day and had Chuck Koenigs come and changed it, Braun will return with parts and repair it. The hydroseeding/grass in the park by the playground is coming real good. Apex will start work on the ball field fence. The tin on the inside of the pavilion has helped a lot to keep the birds from sitting in there and making a mess. Tobe from Bar T Construction will be calling the city office to set a time to shingle the roof, and Clerk Allas will order a dumpster from Thompson.

Council Man Sprung made the motion to pay all invoices/payroll, Council Man Conradt seconded the motion and approved by Mayor Weis.

Council Woman Greenlee made the motion to adjourn at 8:09 pm, with the next meeting to be held Wednesday, July 5 at 5:45 pm., Council Man Conradt seconded and approved by Mayor Weis.
