

Regular Council Meeting November 6, 2023

Pursuant to due call and notice thereof; the regular meeting of the City Council of Rose Creek was held Monday, November 6, 2023, with the following present: Mayor Craig Weis, Council Members: Andrew Felten, Bobbie Greenlee, Mark Conradt, Wendel Sprung, Maintenance Bob Jax, City Clerk/Treasurer Kristine Allas, Kretta Menuey

Mayor Weis began the regular Council Meeting at 5:45 p.m. The Pledge of Allegiance was recited.

Council Man Felten made the motion to approve the Minutes of October 2, 2023, Council Meeting, Council Man Sprung seconded, and approved by Mayor Weis.

Council Man Conradt made the motion to accept the Agenda with the addition of Representative Patty Mueller, Council Man Sprung seconded, and approved by Mayor Weis.

Representative Mueller wanted more background on the speed limit through Rose Creek on State Highway 56, because after Covid, changed to 60 mph from 45 mph (when the school was still open). She will stay in contact with the MN Dept of Safety and hosted a meeting with Jeff Baker, and the legislature starts again February 12, 2024.

Council Man Sprung made the motion to spend around \$2,000 for a new flagpole (so we will be able to lower it when needed), Council Man Conradt seconded and approved by Mayor Weis. City Clerk Allas will order it.

Creek Club: Kretta Menuey gave the report. She asked again for a cell phone booster in the park (from the City or the Fire Department funds). Halloween Spooktacular went well and had a good turnout for the afternoon at City Hall. Rose Creek Cancer Relief Benefit is November 18, 2023, with hot dogs/lunch, chili cookoff, baked goods, and silent auction baskets, cozies design by local residents for 2024. The City is sponsoring a coloring contest also. Santa will be here December 10 and Christmas Caroling at 3 for the shut-ins and will then deliver Christmas goodie box. Will bring up the Christmas Light Contest at the meeting.

Ordinance Committee: reviewing driveway ordinance before next month.

Water/Sewer delinquencies: Council Man Sprung made the motion to assess the list City Clerk Allas has to the Mower County Taxes IF NOT PAID by November 15, there are 9 at this time, Council Man Felten seconded and approved by Mayor Weis.

Mower County Voter Account Agreement: Council Man Conradt made the motion to approve and sign the agreement with Mower County, Council Man Sprung seconded, and passed by Mayor Weis.

Storm Drain between Mergen and B Nelson: Eric Boe has given an estimate of \$3,914.89 and Bruce Nelson has approved Boe to go over his land and back to the drain to intercept – inlet in back with top guard. Council

Man Felten made the motion to approve and for the project to go ahead, Council Woman Greenlee seconded and approved by Mayor Weis. Council Man Sprung made the motion to approve Eric Boe to clean out ditch by NCC fertilizer shed for \$2,811.00 because of too much sediment (to 3rd street) and have Municipal Pipe come in and jet it and grade it to be able to be mowed, Council Man Conradt seconded, and approved by Mayor Weis.


Roger/Dianna Jax asked for their water bill of \$829 (due to toilet running) be waived or adjusted, Council Man Felten made the motion to make no adjustment and for landlords to check on their property more often, Council Man Conradt seconded, and approved by Mayor Weis.

Maintenance Report by Robert Jax: The new lawn mower is here, and is very nice, thank you to the City Council. Council Man Felten made the motion for sand to be ordered and delivered by Pell Trucking for the ball infield, and around the batting cages, Council Woman Greenlee seconded, and approved by Mayor Weis. Mr. Jax asked to be permitted to obtain a quote for a new chlorometer (around \$800) and a new net for Pickleball before spring.

Council Man Sprung made the motion to approve and pay the invoices/claims/payroll, Council Man Felten seconded, and approved by Mayor Weis.

Council Woman Greenlee made a motion to adjourn the meeting at 6:49 pm with the next Regular Council Meeting to be held Monday, December 4, 2023, at 5:45 pm., Council Man Felten seconded, and approved by Mayor Weis.
