ORDINANCE # 56

RELATING TO POSSESSION AND CONSUMPTION OF ALCOHOLIC BEVERAGES
IN THE PUBLIC PARK IN THE CITY OF ROSE CREEK

SECTION 1.

It shall be unlawful for any person to drink or consume non-intoxicating malt liquor or intoxicating liquor ~~in~~ in or upon the public streets, alleys, public buildings and parks or other public grounds of the city, except as is otherwise provided in this code.

SECTION 2.

Licenses may be granted to sell non-intoxicating 3.2 malt liquor at a ball park, public park or other public premises to individuals or organizations on such conditions and limitations as shall be ~~specified~~ specified in the license.

SECTION 3.

No person shall sell intoxicating or non-intoxicating liquor in any public park except when licensed to do so by the City Council of the City of Rose Creek.

SECTION 4.

Alcoholic beverages may be ~~consumed~~ ^{Consumed} in a public park by any person to whom intoxicating liquor may be legally sold in accordance with the state law, except between the hours of 10:00 P.M. and 8:00 A.M.

SECTION 5.

It shall be unlawful for any person, organization or group of persons to bring upon or possess in a park a single container of alcoholic beverages which contains or has a capacity of two gallons or more, unless a permit therefor has been issued to said person, group or organization as hereinafter set forth.

SECTION 6.

All applications for permit to possess in the park a single container of alcoholic beverage which contains or has a capacity of more than two gallons shall be made on forms supplied by the City setting forth the name of the person, group or organization asking for such permit, names and addresses and telephone numbers of those persons who will be responsible for the dispensing of said

alcoholic beverages, and the statement of the public park and specified location in which the same is to be dispensed; and such other information as the common council may require from time to time. It shall be unlawful to make any false statement in any application. Such permits shall be issued by the City Hall.

SECTION 7.


The person, group or organization who have been granted such permit shall display the same at the public park on the site where the alcoholic beverages are being consumed or dispensed. Such permits shall be valid for the time indicated on the permit. Such permits will not be transferrable. The person to whom such permit has been issued shall be responsible to see that said ~~IX~~ alcoholic beverages are dispensed only to those persons who can legally consume alcoholic beverages and shall see that the area where the same is dispensed is kept in a clean and orderly condition and shall be responsible to see that the persons to whom alcoholic beverages are dispensed conduct themselves in an orderly and proper fashion.
