In the event that any property in the City of Rose Creek should become unsightly to the public because it has not been mowed for a two week period as described herein. The City of Rose Creek shall then mow or trim said grass or weed upon said property; the city shall maintain the cost record of said mowing or trimming of each separate lot and said information shall be given to the City Clerk.

SECTION 3. Assessment of Cost; The Clerk shall, if the council should do direct, assess the cost of said mowing or trimming against said property so mowed or trimmed; said assessment shall be certified to the county auditor for collection as other special assessments; no notice of said assessments either by publication or otherwise shall be required.

SECTION 4. All ordinances and parts of ordinances in conflict herewith are hereby repealed..SECTION 5. All ordinances and parts of ordinances in conflict are hereby repealed.

AN ORDINANCE REQUIRING THE MOWING, OR TRIMMING OF GRASS, AND WEEDS.

The City Council of Rose Creek, Minnesota ordains:

SECTION I. Mowing of Weeds and Grass. All owners or occupants of real property in the City of Creek whether said property be vacant or otherwise, shall use due care and diligence to mow and trim all grass and weeds upon said premises; said owners or occupants shall in all events cause said grass and weeds to be mowed or trimmed at least once every two weeks during the growing season; all grass and weeds not mowed or trimmed so as to cause said property to become unsitely to the public shall be considered a public nuisance.

SECTION II. Village to Mow or Trim. In the event that any property in the City of mose Creek amound become unsitely to the public because it has not been mowed for a two week period as described herein, the City of Rose Creek snall then mow or trim salu grass or weeds upon sald property; the City shall maintain the cost record of said mowing or trimming of each separate lot and said information shall be given to the City Clerk.

SECTION III. Assessment of Cost. The Clerk shall, if the council should so direct, assess the cost of said mowing or trimming against said property so mowed or trimmed: said assessments shall be certified to the county auditor for collection as other special assessments; no notice of said assessments either by publication or otherwise shall be required.

SECTION IV. All ordinances and parts of ordinances in conflict herewith are hereby repealed.
